ACTIVITY REPORT:

SANRAL update:

The negotiations with SANRAL are complete. Most of the FPAs have been able to make contact with the relevant SANRAL / contractor route managers and have finalised memberships and established the correct lines of communication. I will ensure that the last few managers have been contacted and once confirmed will report back to Derek Wilson accordingly.

GOFPA / SANRAL update:

There has still been no official response from the GOFPA. No invoice from GOFPA has been received by the WCUFPA so at this stage the funds from SANRAL have not yet been paid over to the GOFPA.

Eskom Transmission update:

We have still been unable to move forward with our Eskom Transmission negotiations. The acting Lines and Servitudes Manager Tony Baloka has been unresponsive and we will now be seeking a legal opinion on this ongoing issue. Braam has kindly contacted Jean du Plessis (who has positioned himself as a Veld & Forest Fire legal expert over several years) and we are hopeful that he will be able to confirm a previous opinion as to where we stand in this matter.

Transnet Freight Rail update:

We continue to iron out the last few discrepancies in order to finalise the total line distances for each depot. Unfortunately this process was stalled over the festive season and we hope to be in a position to invoice TFR soonest.

DAFF Funding Request:

Each of the FPAs have received a draft questionnaire so that we can begin collecting the information required for our DAFF budget request. I will continue to follow up on the outstanding information until we are in a position to move forward in this regard.

Finances:

We are still awaiting the 2015/2016 Annual Financial Statements; the MIS and completed books have been submitted for auditing and SARS purposes. I plan to visit the offices of AJM Financial Services within the next few weeks and will follow up with AJ in this regard.
